Commendations

The Commission commends National University of Natural Medicine for:

- 2. The President's leadership and commitment to transparency.
- 3. Engaging its community of students, staff, and faculty in identifying key criteria when considering potential sites for relocating campus.
- 4. Taking solid steps to examine enrollment and adjust costs over the last several years in order to achieve a balanced budget in fiscal year 2024-25.

- Recommendation 2: Fall 2024 Evaluation of Institutional Effectiveness Develop a practice of longterm financial forecasting, including the impact of a future campus relocation. (2020 Standard(s) 2.F.2)
- Recommendation 3: Fall 2024 Evaluation of Institutional Effectiveness Clarify and systematically
 evaluate the effectiveness of academic advising to ensure that all students have knowledge of and
 access to appropriate programs and services that support their success. (2020 Standard(s) 2.G.6)
- Recommendation 4: Fall 2024 Evaluation of Institutional Effectiveness Develop a process to assess sufficiency of faculty, staff, and administrators to ensure that the institution meets and maintains necessary functions. (2020 Standard(s) 2.F.3)

Recommendation 5: Fall 2024 Evaluation of Institutional Effectiveness - Implement a process to use
institutional student achievement data, including regional and national peer data, to develop a set of
indicators that are used to inform strategies and allocate resources to mitigate gaps in student
