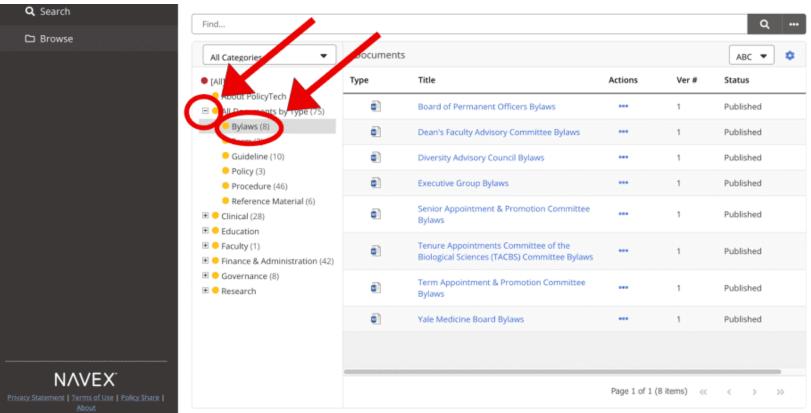
What Does PolicyTech Do?

NUNM uses PolicyTech to automate the handling of policies, procedures, guidelines, forms, and other reference materials. With its rule-based workflows and alerts, PolicyTech ensures that policies progress smoothly through the review process, notifying policy owners about updates or retirements when needed.

A few of the benefits of using PolicyTech:

- Organization and centralization
 - PolicyTech organizes documents and related information in a single online searchable database.
 - PolicyTech aids the NUNM public in finding documents through intuitive search functionality.
- Reduced policy development and review time
 - Reduces the development and review time by using an automated workflow.
 - Automated emails notify co-workers of a document's status, which keeps projects moving.
- Easy and automated electronic document history and archiving
 - When a new document version is created, the software will automatically replace it. Old documents are archived into an online database for safe keeping.
 - Archived versions are easily accessible by system administrators, while employees are only able to access the current versions.
 - The document history is recorded in the solution. Document revisions are stored to provide a clear picture of the document history .

How to Browse



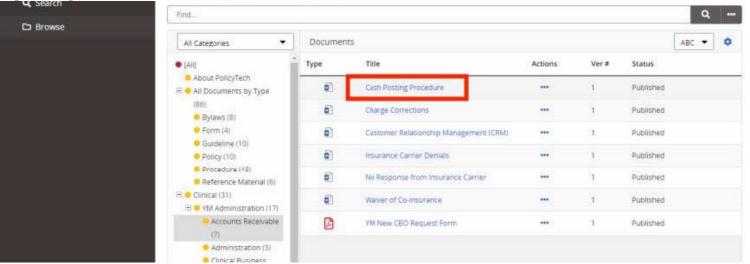
Browse PolicyTech

To browse the documents in PolicyTech, either click a category label (such as "All Documents by Type") or click the "plus" sign next to the category label.

- 1. Clicking the "plus" sign next to the folder title will open the sub-categories of that category.
- 2. Clicking the category title will list all documents in that category/folder.

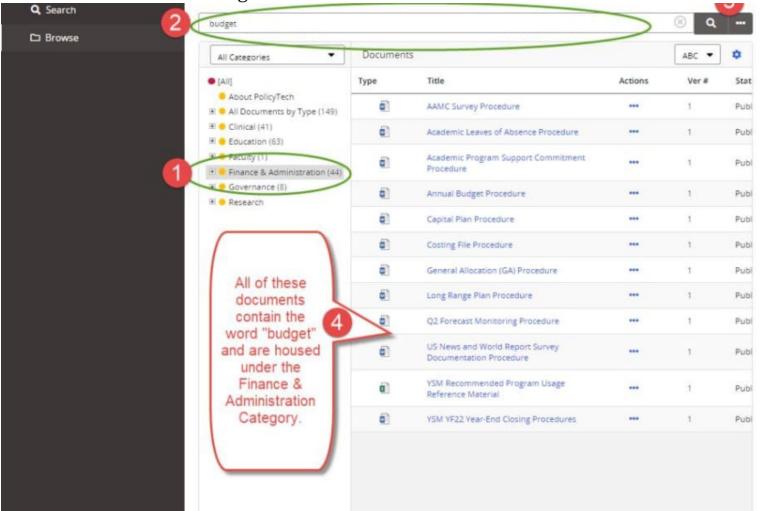

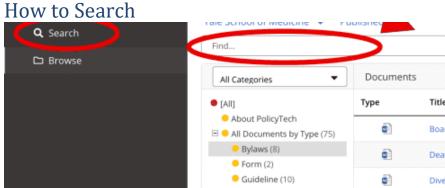
- To search "documents within a specific category":
 - 1. Select Category
 - 2. Enter "keyword" in the "Find search bar."
 - 3. Select the magnifying glass in the top right corner.

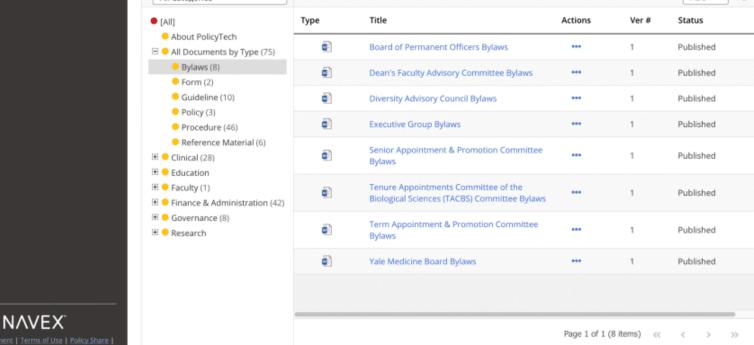
4. All documents that contain that keyword and are within that category will display. If you have a category selected ONLY the documents in that category are searched for by your keyword. The selected category in this case will appear highlighted in the left side navigation.

• To search for a document throughout all PolicyTech documents, choose [ALL] option located at the top of the category list prior to typing in the keyword for your search. This will prompt the system to

search across ALL categories for the relevant document. Then follow the same steps as outlined above (i.e., enter key word into the search bar and select the magnifying glass in top right corner).

Search PolicyTech

Three ways to search: Search from the left navigation, from the "Find" bar, or click the "..." to use the advanced search options.

You can reach search options three different ways in PolicyTech:

• The word: Search

In the left navigation, select "Search," which opens a keyword search bar.

• The "Find" bar

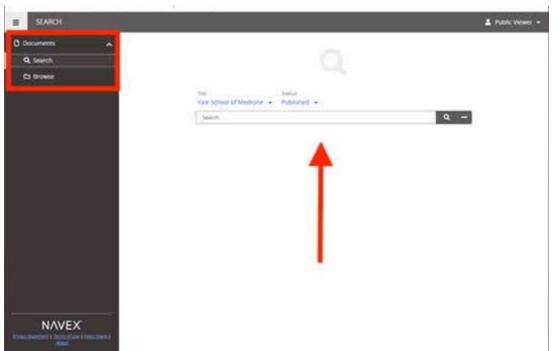
From the "Browse" view, type keywords into the "Find" bar at the top, then hit enter or click the

magnifying glass icon. Clicking the magnifying glass icon by itself displays all public documents in the system.

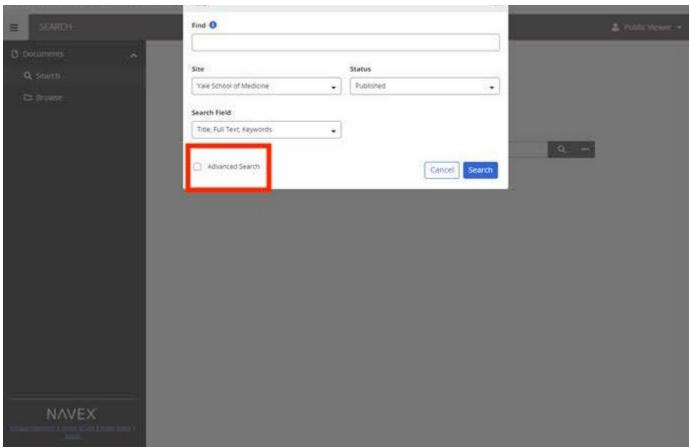
• The "..."

Click the "..." to get the Advanced Search Options.

Search for Document using the "Search" View



• Searching for a document using the "Search" view will always prompt the system to conduct a search across ALL published documents.



• Results can be further refined by clicking on the "..." and then selecting "Advanced Search" Option.

Keyword Search

Keyword searches titles, categories, all text of a document, and tagged keywords:

• Type a single word

This returns a list of documents that contain that word within the title, content, or tagged keywords.

• **Type multiple words** This returns a list of all documents that contain all of those words

- **Type multiple words separated by OR** This returns a list of documents that contain at least one of those words
- **Type a word preceded by NOT** This returns a list of documents that do not contain that word
- Type one or more words in quotation marks

This returns documents that contain that exact text.

Categories and Search

• If you have a category selected and you type a keyword in the "Find" bar, ONLY the documents in that category are being searched for your keyword.

How to Share and Download

In order to share a document via email with another user you will need to copy the url of the document and paste it into your email client. There are two ways to do this.

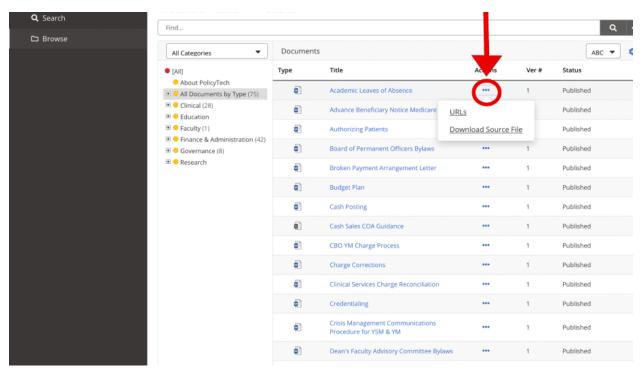

Share from Document View

To share a document via email, copy the url from the address bar of your web browser and paste it into an email you will send.

If you have the document open, copy the url of the document from your browser and paste it into an email client to share.

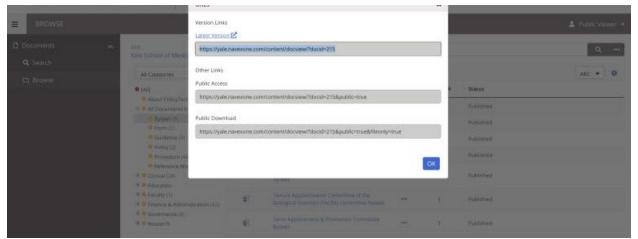

Download and Share

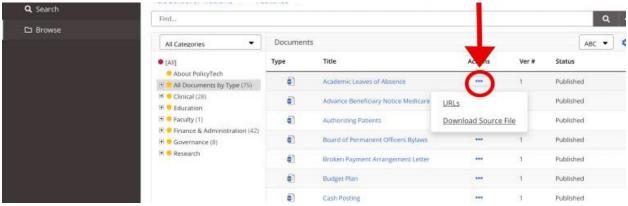
Click the "..." next to the file you want to share or download.

From the "Browse" view, click the "..." in the "Actions" column next to the file you would like to share. Select "URLs" from the drop-down menu, which provides you with three urls to copy. You will usually want to copy the Latest Version to share in your email.

Download a Document



In general, it is recommended that you always view documents in PolicyTech so you are seeing the most updated version of the information. However, if you need to download a document, click the three dots next to the file title you want to download, and select "Download Source File." This will download the file onto your hard drive.
